



# Limited Warranty

## ON GENUINE SUZUKI PARTS OR ACCESSORIES FOR SUZUKI OUTBOARD MOTORS OR GENERATORS

### WHAT IS COVERED:

Suzuki warrants that it will at its option provide, at no charge, a replacement part (either new or rebuilt) or repair any genuine Suzuki part or accessory that is defective in material or workmanship under normal use.

Labor for replacement is also covered if the defective part/accessory was originally sold and installed by an authorized Suzuki dealer.

### WARRANTY PERIODS:

- 1) Marine instruments:  
The warranty coverage for marine instruments extends for a period of 12 months from the date of purchase.
- 2) Apparel:  
Apparel is warranted for a period of one month from the date of purchase.
- 3) All Other Genuine Parts and Accessories:  
The warranty coverage for any part or accessory not listed in 1) or 2) above extends for a period of 3 months from the date of purchase.  
Dealer installed replacement parts or accessories not listed in 1) or 2) above on or for the outboard motor with remaining New Outboard Motor Limited Warranty coverage or on the generator with remaining SUZUKI Limited Warranty, are covered for 3 months from the date of installation, or for the remaining warranty period, whichever is longer.
- 4) Replacement parts do not have a new warranty period. Such parts are covered only for the remainder of the original warranty period.

### WHAT IS NOT COVERED:

- Damage to a SUZUKI part or accessory caused by a non-genuine SUZUKI part or component.
- Labor for replacement of any part or accessory not originally installed by an authorized SUZUKI dealer.
- Any parts and accessories, labor and other cost (such as lubricants) incurred in connection with required or recommended maintenance services as outlined in your owner's and/or instruction manuals.
- Failures or damage resulting from improper installation, removal, repair, misuse, negligence, accidents or modification of the part or accessory.
- This Limited Warranty does not apply where proof of purchase cannot be provided.
- Parts or accessories installed on or for any outboard motor other than a SUZUKI outboard motor.
- Parts or accessories installed on any generator other than a SUZUKI generator.
- Parts or accessories used in an application other than that for which they were designed.
- Parts or accessories installed on any modified or altered SUZUKI product.
- Parts or accessories used for racing competition or rentals.
- Parts or accessories principally used outside the continental United States and Alaska.
- Normal wear or deterioration of any parts or accessories.
- Incidental or consequential damage/expenses such as telephone calls, loss of time, inconvenience, commercial loss, trailering, etc.

### HOW TO OBTAIN WARRANTY COVERAGE:

To obtain the warranty coverage, return the part or accessory to any authorized SUZUKI dealer. (All parts and accessories replaced under this warranty become the property of SUZUKI).

Because warranty coverage periods are calculated on a time basis from the date of purchase, it's required that you provide the proof of the purchase date.

### OTHER WARRANTY TERMS AND STATE LAW RIGHTS:

ANY IMPLIED WARRANTIES INCLUDING THOSE OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE ARE LIMITED TO THE APPLICABLE DURATION OF THIS WRITTEN WARRANTY.

SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, OR THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES SO THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH MAY VARY FROM STATE TO STATE.
